WAVE STATION X INTERVIEW
OF JOHN GREGORY LAMBROS

1. You mention that this ordeal started after your arrest in Brazil ... What was your reason for being in Brazil and why were you arrested?

I was contracted to assist a group of Americans in the packaging of a pharmaceutical company, that is coordination of legal consul, financial resources and bringing the company public in Canada and the United States. I was a licensed stock broker and investment banker on federal parole in Minneapolis, Minnesota that choose to move to Brazil so as to complete the arrangements in structuring the pharmaceutical company with the legal opinion that a parole violation was not considered a crime in Brazil. I was arrested on a Federal Parole Violation that is currently pending in Federal Court. After my arrest the U.S. and Brazilian Government presented me with charges of cocaine conspiracy.

2. You mentioned that you were then tortured ... can you tell "us" how soon the torture started after your arrest and what it consisted of ...

I was arrested at the Rio de Janeiro, Brazil airport in May 1991 and placed in the Brazilian Federal Police Station for 58 days and then forceably transferred/kidnapped to the Brazilian Federal Police Station in Brasilia, Brazil to what is known as one of the 200 plus torture interrogation centers within Brazil.

The Brazilian Constitution is very similiar to the U.S. in that if you are arrested in one state you may not be transferred to another state without appearing before a judge and going through a extradition type of proceedings which would include a bail hearing. I was given a \$ 50,000.00 bail bond by the judge in Minnesota that the Brazilians would not honor.

It was within the Brazilian Federal Police Station in Brasilia, Brazil that I was DEPATTERNED within the DEPATTERNING/GRID CELL that had been constructed in the late 1960's by the U.S. Army Corps of Engineers in OPERATION CONDOR, the sister project of PROJECT PHOENIX in Asia. During the 1960's in Brazil, U.S., German, Russian and French military started to implant and DEPATTERN humans. This also occurred throughout South America.

Your next question is probably, what is DEPATTERNING and how does it affect humans? In the simplest of terms, your brain gives off both electrical and magnetic signals that can be recorded within a DEPATTERNING/GRID CELL or CHAIR. For example, as you lift your right hand, your brain is coordinating your comand in the following lay sequence:

1. Orbital frontal lobe makes determination/decision.
2. Premotor area (6 of frontal) plans it.
3. Motor area (4 of frontal) executes it by telling.
4. Motor neurons of ventral horn of spine to order muscle movement.

If you record the above sequence you then can transmit same back to the person via satellite and make them perform that movement. This is where the term "SATELLITE PRISONER" comes from. Now just imagine if you record every movement of a person day in and day out so you have a virtual library of a person and able to control each and every body function of that person at your will. This is known as HIGH-TECH SLAVERY. The government has eliminated the need for chains and hand cuffs.

The implant(s) serve in two (2) functions, One (1) as a communication device and two (2) to receive and transmit signals to the brain. May I suggest reading GORDON THOMAS book JOURNEY INTO MADNESS, The True Story of Secret CIA Mind Control and Medical Abuse. Pages 276 thru 279 of THOMAS book offers an overview of implantation by Dr. Heath, a neurosurgeon at Tulane University and Dr. Delgado in the 1960's and early 1970's. It was in the mid 1970's when the governments of the world started destroying records of mass implantation of humans. The theory being in implanting everyone is to be able to track, with psychological data being transmitted from the person to a central BIG BROTHER that dictates your everyday options. These facilities are currently in existence in the U.S. and other countries.

My Web site offers an excellent document entitled "ANYONE OUT THERE HAVE IMPLANTS" as to the functions performed by implants. May I suggest that we offer those listeners that have an INTERNET access to pull-up the document on my site so they may have a better understanding: (offer Web address for Boycott Brazil)

Please note that the implants are usually used to kill persons after all information has been extracted and the persons use has been completed. Please note number 9 in ANYONE OUT THERE HAVE IMPLANTS, IMPLANTS MAY BE USED TO SPEED UP THE BODIES FUNCTIONS IN THE AGING PROCESS SO AS TO DESTROY A PERSON WITHOUT THEIR KNOWLEDGE. As you can tell, I have aged extensively and my controllers do not allow me to defecate so as to poison my internal organs gradually.

Milder forms of torture were used within Brazil along with my continued 24 hour a day interface with my handlers.

3. You mentioned that implants were surgically implanted in your brain to interrogate, monitor and control you. Were you awake during this operation, and if not, when did you first realize that you had said implants?

I was not awake and believe I was given a sleeping pill in my food at the Brazilian Federal Police Station in Brasilia, Brazil. It is my understanding that the implants are inserted through the nose into the Brain.. It was only a few days after I was forcefully taken to Brasilia, Brazil when the police started to interface with my brain and body.

4. You mention a massive cover-up by the CIA, The Department of Justice, the State Department, and the government and Courts of Brazil. Do you have any concrete proof of this?

During my trial, Judge Murphy issued a SUBPOENA for U.S. counsel person Margaret Murphy of the U.S. Embassy in Brasilia, Brazil to appear at my trial to testify as to my forced implantation and torture. Margaret Murphy refused to attend my trial. I currently have requested the Court to issue an arrest warrant for Murphy so she will testify at my resentencing. The Court will not respond and my torture continues daily. Judge Murphy was supplied with x-rays of my implant by the U.S. Bureau of Prisons and has refused to have experts review same. I have even requested U.S. Senator Jesse Helm and past Senator of Kansas Kassenbaum to intervene to no avail. As you know, both Senators are on the Foreign Relations Committee. If thats not a cover-up what is?

In November of 1996 I filed a \$500 Billion COMMERCIAL LIEN ON BRAZIL et. al. so as to tie-up there credit and have served them 90 day notice in December 1996. You may review same by accessing my new Web site called BRAZIL LIEN at:

The Web site should be up and running by January 10, 1997. The lien has been used effectively by MILITIA GROUPS in the U.S. against Judges and prosecutors in forcing them to do there job.

As the girls on the street say "NO MONEY NO HONEY" is the type of law offered to me in Brazil so I have basically turned the game on the assholes.

5. There seems to be more people than yourself who share this claim of having been implanted. Do you communicate with the others in an effort to fight this and get it out to the public?

BRIAN WRONGE, was my first success in contacting another implant victim. Please turn to my Web site under Brian Wronge and read the articles on Wronge that were printed by THE CITY SUN NEWSPAPER. Wronge was a former prisoner at correctional facilities in New York from 1979 to 1989 when he was implanted. As myself, Doctors found "PARAMAGNETIC METALLIC FOREIGN BODIES" within his skull and chest. Two labs confirmed same with MRI and CT scanning methods. Wronge also has miniature radios implanted in the membrane of the eardrums according to a research biologist. I wouldn't be surprised if five or ten percent of your listners have been implanted with same due to the CIA-funded experiments that started in Utah in the 1960's.

Also within the Boycott Brazil web site you will find a list of approximately 17 other victims of mind control abuse and implantation under the MIND CONTROL RESOURCE DIRECTORY. Links have been provided to some of the victims that have web sites.

6. You mention mind control, can you elaborate on some of the things you have experienced? I mean, without being obtuse do you receive television or radio signals, and if so do you get the cartoon network?

During the first three years my handlers worked heavily on

breaking me, trying to turn me into a raving maniac in using my family activities against me. For an example, my mother is a horror and using and giving picture of my mother with black men and groups of men and then they reverse the scenario with my father, brother and sister. All of which is not true.

The brazilians are capable of patching any type of image into me at any time of the day or night with sound. They are to constipated to give me any of the three stooges or road runner series. This form of technology is known as "TELEPATHIC LINK" within the science of CYBER.

My controllers also only let me function at approximately 25 to 35 % of my capabilities thus not allowing me to maintain and assist in my legal defense in the mode I am accustom to. Remember my total vocabilary is programmed and I am only allowed to use a portion of same and restricted in many areas.

MIKE, I'm sorry but I will have to finish this interview tomarrow as the Brazilians are making it very difficult for me to concentrate and infusing headaches and body pain. Please forward this to the powers to be at the radio station and offer my assurance that the second part of this interview will be completed for the following WAVE STATION X show on Monday. Hopefully the listners will have questions that I will try to address as we monitor here at USP Leavenworth.

7. Months ago, a lady by the name of Cathy O'Brien came forward with claims the CIA raised her and other young girls as sex slaves for men throughout the world. Are you familiar with her claims. If so, elaborate on your thoughts. If not, do you think its possible, what she claims?

Here is the December 16, 1996, U.S. Certified Mail letter to Cathy O'Brien and Mark Phillips I wrote after reviewing their book "TRANCE, FORMATION OF AMERICA BY PHILLIPS & O'BRIEN". My handlers, those that control me, would not let me process all the information within their book so I thought it best to write Cathy and Mark for assistance and feedback.

May I suggest that you read my Dec. 16, 1996 letter to Cathy and Mark to your listners and post it on your Web site for downloading.

I believe Cathy was used as a sex slave, to what extent I don't know, as the Brazilians use sex slaves on a regular basis with full knowledge of the Catholic Church. What troubles me in Brazil is why the Catholic priests don't use girls instead of screwing young boys in the ass.

One of my girl friends lived in Brasilia, Brazil the capital of Brazil and ran the escort service for most of the foreign embassies and the National Hotel, which is the most exclusive hotel in Brasilia. As I reflect back to some of the actions of the girls, as I lived with several of them for a few weeks and visited the office on a regular basis, I think some of the girls could of been implanted. It is not unusual for two to five girls to be dispatched to entertain a foreign visitor or a wealthy Brazilian in creative play.

The Catholic Church has full knowledge of the forced implantation in Brazil and the World and uses the technology to obtain anything it wants. The Catholic Church makes the prisoners in Leavenworth look like kindergardeners.

I would suggest reading Cathy and Marks' book "TRANCE - FORMATION OF AMERICA" after you have read about other victims of Mind Control via THE MIND CONTROL FORUM Web site that is linked to my Web site.

8. Yahoo has just named your internet sight one of the most interesting new sights on the Web. Have you noticed an increase in "hits" on your web site since you were named "INTERESTING". What kind of responses do you get from all this?

I think it was the first week on December 96, that my attorney notified me that Yahoo notified him of our status as being listed within the TOP 100 NEW AND MOST INTERESTING WEB SITES. It is my understanding that we will keep that status for 30 days. The BOYCOTT BRAZIL Web site is averaging about 20 plus hits per day and we are also registered in all of the free search engines thru Submit-it. I would appreciate any and all assistance from your listners in supporting my boycott against Brazil and passing the word about my site and cause.

Other victims have started to surface and a mind control victim by the name of ED LIGHT has coordinated a Web site by the name of THE MIND CONTROL FORUM that offers an overview of victims and resource material. You may want to contract Mr. Light for a telephone interview.

9. I remember before I met you, I had heard about you from other inmates. As for your astounding claims, I can remember varied reactions. Some believe you whole-heartedly, some really weren't sure what to believe, and then there were those who believed the butter slipped off your biscuit. How has the reactions from people affected you and your cause since coming out with your story, and is it frustrating that more people don't sit up, take notice and listen to what you have to say?

I'm sure your first reaction was that the butter slipped off my biscuit! I'm sure that is what the Brazilian and U.S. Government want everyone to think with the end result being to force me to take medication and go crazy. My 24/7 abuse is degenerating my body, thinning the walls of my veins and killing brain cells so I really don't know to what strata my mental awareness has regressed to, except that I keep shoving legal motions up the governments ass daily to the best of my ability. In fact, I was notified today that more documentation has been posted within my Web site for the publics review. Due to the fact that I'm only limited to selected memory and voided of all legal case cites unless I return to notes, I do my best to maintain stability and help others to understand past research in mind-control so they at least can formulate an understanding of the existance of same.

If it wasn't for the INTERNET and my Web site I could not of afforded to accumulate the supporters I have to date.

10. Apparently the experiment got screwed up somewhere ... I mean, if it was meant to control your thoughts, surely the builders didn't mean for you to be this outspoken. What do you think went wrong?

Tenacity has always been one of my strongest fortitudes thus one would have to kill me to stop me no matter how little I am allowed to accomplish. My controllers stated to Minnesota Federal Judge Murphy at sentencing that I was being used as a political puppet and I don't understand why as it is a no win situation for everyone. Remember I have the \$500 Billion Lien against Brazil that will literally stop commerce for Brazil this year and it will be very difficult for the Feds to step in. Stay tuned to my Web site.

11. Upon glancing at some of the things you have on your Web site, a few things caught my attention. Can you elaborate on what you had to say to the F.C.C. and what is the U.S. Government PINE GAP BASE IN AUSTRALIA, and can you explain what MK-ULTRA is?

About two (2) years ago I started to contact the F.C.C. for assistance after another inmate in the law library suggested that we explore laws surrounding radio waves entering the U.S. ~~and the laws regarding the same~~. Initially the FCC was somewhat receptive and assisted in untangling the web of agency structures that govern the laws regarding who is to monitor and control what then I started to supply proof of past radio telemetry projects and other victims and they started treating me like a step-child with bad breath.

The PINE GAP BASE IN AUSTRALIA from my understanding is very similar to that of AREA 51 that is run by JAMSON SCIENTISTS. The book that released the information, which the Brazilians are blanking from my mind but available via my Web site, states that persons that work in the facility are implanted due to the TOP SECRET projects that are conducted. Please refer to the article within my Web site entitled "ANYONE OUT THERE HAVE IMPLANTS?" for an overview of functions implants are capable of. Basically it is done to control all memory of the human so they will never be able to share the information.

MK-ULTRA was a CIA project under the name of National security that started out using drugs on the public in the US and overseas in the late 1950's. The project progressed into implantation and depatterning in the 1960's with a company by the name of MANKIND RESEARCH UNLIMITED, Inc. 1315 Apple Avenue, Silver Springs, MD. 20910, Tel. (301) 587-8686 providing most of the contract scientist for the projects. DR. Jose Delgado, a Yale psychologist and Dr. Robert G. Heath, a neurosurgeon at Tulane University were the lead project directors in the implantation of humans. Dr. Heath had actually implanted 125 electrodes in the brain and body of a single patient - for which he claimed a world record - while spending hours stimulating the mans pleasure centers. They are both known as butchers. Again I am suggesting your listners and readers if this is posted on your Web site to review my site and the links to the other research sites.
