Dear Mr. Lambros:

Perhaps I exaggerated in my last letter to you. Perhaps you could not be out of prison by now. What I was trying to communicate to you is my "admiration" for the tremendous effort you have made to discredit the Brazilian government for its complicity in torturing you, and my frustration with your inability to comprehend that Brazil does not have a sophisticated electronic industry, that agents of the U.S. Marshall's Office or the Drug Enforcement Agency or the C.I.A. were torturing you in the Brazilian prison where you were held pending extradition, and that they are continuing to torture you in Leavenworth. Brazilian authorities are but a footnote to your real story!

There is virtually nothing that I can do to help you as long as you contend that Brazilian agents or Greek Orthodox priests are torturing you inside of an American, maximum security prison. Can't you comprehend that the structure of your thinking is not sane? I have received no other complaints from Brazil of being tortured with the weapon which you have described to me, and I receive complaints from many other countries.

Try to pull yourself together! The same effort put into stopping torture in the United States and by the United States would have at least stopped your torture by now. You have excellent organizational skills but they are being misdirected.

I am going to discuss your file with someone who may be able to help you, but I can tell you in advance that you have already done such a good job of proving yourself delusional that helping relieve your condition may well be impossible.

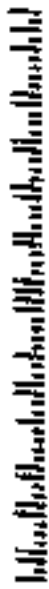
