RE: ARE BRAZILIAN'S RESPONSIBLE FOR IMPLANTING JOHN GREGORY LAMBROS?

Dear Boycott Brazil Supporters:

For the past few months I've received an increasing amount of correspondence asking why John Gregory Lambros was implanted with brain control implants and why I think Brazil is responsible.

In 1995 and 1996 I filed over thirty (30) Freedom of Information Act requests with agencies within the United States Government. Most of the information I received was of little assistance but one (1) document released from the U.S. Department of Justice, Drug Enforcement Administration on October 02, 1996 and attached to a October 25, 1996 letter offered insight as to why the Brazilian Government implanted John Gregory Lambros. The DEA request number 96-0569-C document offered the following information:

1. Document from DEA Minneapolis, Minnesota to DEA Washington and Brasilia, Brazil;
2. John Gregory Lambros is a federal fugitive in DEA Case LJ-86-2001;
3. It is believed Lambros is living under an unknown false identity in Rio de Janeiro, Brazil; (Not true as Lambros was conducting legal business in Brazil)
4. Lambros should be considered armed and dangerous; (not true as Lambros has never carried a gun in his life except for hunting)
5. Lambros has fired upon DEA Agents in prior arrest situation, WITHOUT striking any personnel; (Lambros fired at DEA agents when they attempted to enter his home at 10 p.m. after misidentifying themselves. When Lambros asked who was at the door, the U.S. Marshal stated, "Jim, Open-Up.");
6. Lambros is possibly using the name "Hans" in Rio de Janeiro, Brazil and involved in the continuing attempt and/or actual manufacture of Pentanyl at or through the facilities of a company known as BELTICO. (Lambros has never used the name "Hans" and was contracted as the investment banker in the manufacturing of Pentanyl for distribution within Brazil and other countries that do not have copyright and trademark laws. Brazil did not have copyright or trademark laws until 1994);

6. "it is fully anticipated that such investigation should be beneficial in locating Lambros, and also be **PRODUCTIVE IN THE LOCATION AND DISABLING OF AN ON-GOING FENTANYL LABORATORY.**" (First of all there was no laboratory in Brazil, as the world renown chemist BELTICO contracted would not work in Brazil due to working conditions and equipment availability, thus the Fentanyl was manufactured in the United States to be shipped to Brazil for distribution. In fact, the chemist was requested to fly to the United States from Germany to stand trial, in which he was found not guilty, as Fentanyl manufacturing in Brazil is legal and to the best of my knowledge BELTICO had secured all licenses required for the distribution of Fentanyl in Brazil and the export of Fentanyl from Brazil.)

It is Lambros' belief that the U.S. Government requested Brazil to implant Lambros when he was arrested to obtain the location of the alleged "ON-GOING FENTANYL LABORATORY."

John Gregory Lambros' total involvement was to assist in the marketing, funding, and public offering of BELTICO and/or a distribution company in marketing Fentanyl throughout Brazil and other countries in South Africa and the Middle East that do not have strict copyright and trademark laws. As you know, Fentanyl has been used in-place-of morphine in many third and forth world countries.

Attached for your review is Freedom of Information Act release from the U.S. Department of Justice, Drug Enforcement Administration, Request No. 96-0569-C, three (3) pages total, cover letter and two (2) page release.

Boycott Brazil supporters are requested to contact John G. Lambros as to there thoughts.
